Sannitriveni Rural Municipality invites electronic bids from eligible bidders for the construction of Sannighat to Rural Municipality Road Upgrading Project under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 2081/10/20 (Feb 2, 2025) Electronic bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs. on 2081/10/20 (Feb. 2, 2025) at Sannitriveni Rural Municipality Mehalmudi, Kalikot. Bid validity period and Bid security validity period for bids shall be 90 days and 120 days from bid opening date. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
